A peer review is a periodic, independent evaluation of a CPA firm's accounting and [auditing](#) practice. In most states, peer reviews are required by state boards of accountancy and CPA societies as part of firm licensing and membership requirements.

The purpose of a peer review is to determine whether a firm's system of quality management is designed and operating effectively, and whether its accounting and auditing work complies with applicable professional standards.
